## **1. Overview**

Beechwood Park School ('the School') acknowledges the importance of sun protection and aims to ensure staff and pupils enjoy the sun safely. This policy aims to protect pupils, so far as is reasonably practicable, from the dangers of exposure to the sun. It does not seek to address the issue of insufficient sun exposure.

This policy is based on the SunSmart guidelines from Cancer Research UK.

Too much ultraviolet (UV) radiation from the sun can damage skin cells and cause skin cancer. In the UK, almost 9 in 10 cases of melanoma skin cancer could be prevented by staying safe in the sun and avoiding sunbeds.

## **2. Application and accessibility**

This is a whole-school policy including the Early Years Foundation Stage (**EYFS**). It relates to sun protection whilst pupils are on the premises during school hours, undertaking school activities and after-school clubs (including holiday clubs) and when away from the School, for example, on an educational visit.

Throughout this policy, we refer specifically to pupils. However, for their own protection staff should follow this policy and the guidelines developed by the School. References to parents in this policy include carers.

## **3. Aims**

- To present information to parents, pupils, and staff about enjoying the sun safely.
- To encourage pupils to take responsibility for their own safety based on a clear knowledge and understanding of the dangers.
- To incorporate knowledge of sun care into other curriculum areas and discussion opportunities.
- To ensure pupils are aware of the dangers of the sun and how to protect themselves against these both when at school and in other settings, such as trips and residential visits.

## **4. Partnership approach**

- Sun safety will be promoted through working with parents and the wider community where applicable to improve our understanding of and ability to avoid the harmful effects of too much exposure to UV light.
- Pupils will be asked by staff to wear sun hats and self-apply sunscreen when and where appropriate.
- Staff should act as positive role models and set a good example by seeking out the shade wherever possible and wearing suitable clothing, a hat and sunscreen, particularly during playtime supervision and when teaching outside.
- Pupils are outside for outdoor play each day. In addition to this, pupils are outside for any of the following: Games, P.E., matches, some after-school clubs and outdoor educational activities. Consequently, it is very important that the School and parents work together to protect pupils from the harmful effects of exposure to the sun.
- Parents should support this policy to protect their children by:
  - Being positive role models in relation to sun safety.
  - Applying sunscreen to their child or ensuring the child applies it to themselves before school each day during the summer term and at other times when the weather requires it.

- Providing their child with sunscreen (in a named bottle and at least factor 30) to keep at school during the summer term.
- Providing their child with a named school hat.
- Informing the school of any medical issues relevant to this policy, for example, skin conditions, sensitivities, or allergies to sunscreen.

**The School will work with staff, pupils, and parents to achieve our aims as follows:**

## **5. Education**

- Education will be provided in a format appropriate to the age and stage of the pupils.
- The benefits and risks of exposure to the sun and the importance of sun protection will be taught through our PSHE and Science curriculum and reinforced during form time.
- Information on sun safety, alongside copies of this policy, will be available on SharePoint.
- The School will highlight the importance of enjoying the sun using assemblies, form time, posters around the School, poster competitions and information sent to parents. We will continually review how we raise awareness, encouraging pupils to contribute ideas during House meetings in the Prep School and assemblies and form time in the Pre-Prep.
- Sun protection posters will be placed around the School during the summer term.
- Parents will be aware of this policy and encouraged to work in partnership with the School as set out in section 4. Further information for the whole school community can be found here:

## **6. Protection**

### **▪ Shade**

- The School has numerous shady and woodland areas. There is a covered play area at the Nursery. When the sun is strong, pupils will be encouraged to sit / play in the shade where it is available.
- Sunbathing is not permitted.
- The School has pop-up gazebos which are used to provide shade at outside events. In extreme heat we will use gazebos to provide shade during Games lessons and matches.
- The School will regularly review the available options for the provision of shady areas around the school.

### **▪ Clothing**

- All pupils must wear hats in hot, sunny weather when participating in any outdoor activities. School hats (bearing the School logo) are compulsory uniform items for pupils in Years 7 and below and can be purchased from the School's uniform supplier, Stevensons. Year 8 pupils must also wear a hat to protect their faces and head, but it may be a hat of their own choice.
- The School has a limited supply of spare hats, should a pupil misplace their hat.
- Parents will regularly be reminded to provide a named hat for their child.
- Sunglasses will not be encouraged, but children may wear them at playtime (particularly those with hay fever).

## ▪ **Sunscreen**

- A letter will be sent by the School Nurses to parents at the beginning of the summer term, reminding them to apply sunscreen to their children before they come to school when the weather requires it, and to provide a named bottle of sunscreen for the child to reapply themselves at regular intervals when necessary.
- Parents and staff should ensure when buying or using Nivea Sun Kids Protect & Care that they choose a bottle that is clearly labelled 'New Formula'. These products no longer contain almond oil. Any Nivea products that are not labelled 'New Formula' should not be used or bought into school as they may contain almond oil. (Please see Appendix 1 for further information.)
- The School has supplies of sunscreen should a pupil misplace theirs. Consent for suncream is covered under the provision of homely remedies (see Parent Handbook) unless you have informed the School Nursing Team (in writing) that your child should not use suncream.
- Pupils need to be encouraged to learn how to apply sunscreen as staff are not permitted to apply sunscreen to pupils. Staff are encouraged, where appropriate, to supervise the application of sunscreen and to teach pupils how to apply it.
- Sunscreen use will be encouraged on days when the sun is strong for PE lessons, school trips and other outdoor activities and events. Extra sunscreen will be provided as part of the first aid provision, if a pupil forgets their own.
- Parents will be reminded to apply sunscreen to their child or ensure their child applies it themselves on the morning of a school trip. Staff will be provided with sunscreen so that pupils can reapply it during the day, as part of the first aid provision.
- A sunscreen of at least factor sun protection factor 30 with a 4 or 5-star rating is recommended and should be applied generously and regularly.

## ▪ **Drinking water**

- Pupils should have a named water bottle in school throughout the year, and should also bring these for school trips. These can be refilled at school and are regularly sent home to be cleaned.
- Pupils also have access to water from the water fountains and coolers around the School.
- Pupils are provided with a drink of water at all break and lunchtimes.
- Staff will remind pupils to drink regularly, particularly in hot weather and will explain the importance of this.
- Staff who work outside for long periods of time are encouraged to keep a bottle of water with them to stay hydrated.

## **7. Monitoring and Review**

The School will monitor this policy on an ongoing basis, taking into account the recommended guidelines from the relevant authorities and organisations. The School will regularly review the effectiveness of this policy and how it can be improved.

## Appendix 1

### NIVEA SUN KIDS PROTECT & CARE - ALMOND OIL STATEMENT

As the World's No.1 Sun Protection Brand\*, we're always looking at how we can further improve our formulas to provide the best products for our consumers.

After listening to customer feedback, we have removed Almond Oil from all NIVEA SUN products. This change was initiated in December 2023, and all newly produced items no longer contain almond oil. These updated products are clearly labeled with a 'New Formula' message on the front and state "Does not contain Almond Oil" on the reverse.

Consumers should be aware that some stock from last season may still be present in stores. Any products containing Almond Oil are clearly labeled with "Contains Organic Almond Oil" or "With Organic Almond Oil" on the back of the bottle.

If in any doubt, our NIVEA SUN Babies & Kids Sensitive Protect range, which has never contained Almond Oil, may be a more suitable alternative. This range is easy to identify as it comes in white bottles.
